Qualified / Valid GPAT/GATE or other National Fellowship examination Score card must be uploaded in the Online Application Portal which will be enabled on the NIPER JEE 2023 website w.e.f. 14<sup>th</sup> (11:00 AM) to 17<sup>th</sup> July 2023 (5:00 PM). After the specified due date, no request for uploading of the same will be entertained.**
- 2. Candidates, who mentioned as “APPEARING/APPEARED” in the qualifying degree status at the time of filling the online Application form must be updated as well as upload their final qualifying degree status and certificate in the Online Application Portal which will be enabled on the NIPER JEE 2023 website w.e.f. 14<sup>th</sup> (11:00 AM) to 17<sup>th</sup> July 2023 (5:00 PM). After the specified due date, no request for uploading of the same will be entertained.**

**NOTE:**

- a) This is not applicable for the candidates who mentioned as “**COMPLETED**” in the qualifying degree status at the time of filling the Application form.
- b) Candidates failing to submit valid /qualified GPAT/GATE/National Fellowship certificate and final declaration of passing of the qualifying degree on or before the above-mentioned date will not be considered for the counselling process.
- c) Candidates whose final qualifying degree results are already declared but no certificates are received are requested to upload the result declaration document or certificate from competent authority of college or institute or university confirming that the final qualifying degree results of the candidate are declared, and he/she has passed the same.

**3. Status of the Reserved candidates against the submission of the Reservation Certificates during online application or vide E-mail communication as on 10-7-2023 (4:00 PM) for the various categories are updated on NIPER JEE official website.**

- **Status of the PWD candidates may be checked in the respective reserved category.**

**Note:**

1. Candidates whose reservation status is “Applied For”/ “Receipt Submitted”/ “Not Accepted”/ “Not Submitted” can submit their final valid certificates on or before 16<sup>th</sup> July 2023 up to 5:00 PM from the link available in the NIPER JEE official site.
2. OBC and EWS certificate must be as per the central Govt. format and should have validity of minimum one year from the date of issue to 15<sup>th</sup> August or it may be issued under the current financial year i.e., after 1<sup>st</sup> April 2023.
3. Candidates failing to submit their respective reservation certificates on or before the above specified time will be considered under General category.
