1. **Nationality:** Only candidates of Indian Nationality are eligible to apply for these positions.

3. **Application Mode:** It is mandatory to submit applications **online through the included Google Form**. No other forms of application will be entertained. Candidates are advised to keep high-quality scanned copies of all required supporting documents ready before starting the application process.
4. **Eligibility Verification:** Candidates must ensure they meet the minimum essential qualifications, age, and experience criteria as laid down in the advertisement. Screening will be based strictly on the data submitted in the application form. Providing false or incorrect information will lead to immediate rejection of the candidature at any stage of the recruitment process.
5. **Finality of Submission:** Once an application is submitted, it cannot be altered or resubmitted. No requests for changes to data or particulars will be entertained after the final submission.
6. **Documentation:** Incomplete applications or those missing self-attested supporting documents (e.g., Proof of Date of Birth, Degree Certificates, Mark Sheets, and Experience Certificates) will be summarily rejected.

7. **Relaxation of Criteria:** Upon the recommendation of the Screening/Selection Committee, the Competent Authority reserves the right to relax age and experience requirements in exceptionally meritorious cases.
8. **Selection Prerogative:** Meeting the minimum qualifications does not guarantee an interview call. The Institute reserves the right to set higher benchmarks for shortlisting and the right not to fill any of the advertised positions due to administrative exigencies.
9. **Communication:** All official intimations will be sent exclusively via Email or hosted on the Institute website. Candidates should regularly check their registered email and the NIPER Guwahati website for updates.

14. **Interview Mode:** Interviews will be conducted in a **hybrid mode (both physical and online).**
