Duties & Responsibilities of Anti-Ragging Squads in NIPER Guwahati

3. Discreet random surveys to be conducted amongst the freshers' during the assigned duty period, for knowing their well being.
4. Anti-Ragging squads should ensure that none of the above mentioned activities are initiated by any student of the institute. Acts amounting to Ragging could be:

- Teasing, Embarrassing and Humiliating
- Assaulting or using force to criminal intimations
- Wrongfully restraining or confining or causing Hurt

Note: The above committee will visit the hostels at the assigned dates and record their visit in a register maintained by the respective Hostel Wardens.
