- 4. Full documents verifications will be done for provisionally selected candidates directly at AMTZ, Vishakhapatnam, A.P. Therefore, selected candidates are requested to bring all educational qualifications mark sheets, certificates, proper work experience certificates in original as well as a set of photocopy of all the documents for both verification & submission at AMTZ for further physical joining subjected to qualification.
