- SUBMISSION OF BIDS:** The signed and sealed techno-commercial bids should be submitted in a sealed envelope super scribed with "**Quotation for Painting of Exterior and Interior Walls of Animal House, NIPER-Guwahati against CPPP Tender ID \_\_\_\_\_**" and addressed to the *Director, National Institute of Pharmaceutical Education and Research (NIPER)-Guwahati, SilaKatamur, Halugurisuk, Changsari, Kamrup, Assam-781101, INDIA* so as to reach this institute on or before **28<sup>th</sup> August 2024 (Wednesday) up to 11:00am** and shall be opened on the **same day at 11.30am** in Stores and Purchase Department, NIPER Guwahati.
- COMPLETION OF WORK:** The work should be completed within **1-week** from the date of receiving the order. Compensation for delayed work will be 1% of the order/ contract value per week.

The necessary crack repairing work in the wall surface including making necessary groove, applying putty or filling sealant powder, wherever required shall be carried out by the vendor and nothing extra shall be paid for the same. Any damage done during execution of the work/ repairs is to be made good by the agency and nothing extra will be paid separately for the same.
