

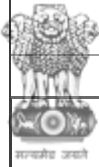

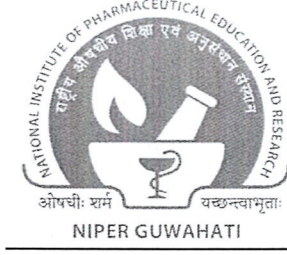

Bidders are required to be present at the auction site, in person, along with original and one photocopy of their Identity proof such as Adhaar card, PAN or any other photo identity issued by Govt. of India. They should record their presence in the register maintained for this purpose with the Authorized NIPER Official and along with a letter head of the firm.

Only bidder who have marked their presence and have deposited a refundable entry fee of Rs. 5000/- (Rupees five thousand only) in the form of DD in favour of Director NIPER Guwahati payable at Guwahati will be entitled to participate in the bid process. However, in case of any unruly behavior by the purchaser during the auction, the deposit of Rs. 5,000/- (Rupees five thousand only) shall be forfeited by NIPER Guwahati apart from taking any other action for controlling such behavior.

Terms and conditions of auction sale at NIPER Guwahati

1. The auction will be conducted at NIPER Guwahati for scrap materials (cardboard box/wooden packing materials, carton) on per lot basis and on "as is where is basis" by NIPER Guwahati Official(s) on behalf of Director NIPER Guwahati.
2. The Purchaser participating in auction should know all the terms and condition of auction and should be aware of condition of the scrap materials to be auctioned. It is the responsibility of the purchaser to have satisfied themselves in all respect of the lot i.e. quality, quantity, lot condition, location, etc. before bidding for the lot. NIPER Guwahati will not be responsible for the incorrect weight, description, genuineness, authenticity or any fault or defect in any lot and make No warranty what so ever. Should any mistake, whatever, be there in describing a lot either in the hand-bill, catalogue or at the time of sale, especially in stating the quantity or quality, such mistake will not be held to vitiate or affect the sale in any way, it being understood that the intending purchases have been satisfied themselves in all respect before bidding for the lot. No complaint/claim by the purchasers will be entertained in the regard after sale of lot.
3. Purchasers are advised to inspect the lot available at the site prior to bidding, between 1000 hours to 1600 hours on any working day except- Saturday and Sunday.
4. Should any dispute arise between two or more bidders, or for any cause arising in the course of auction, the auction supervising officer shall have the right to put the lot again for auction or to withdraw the lot.

5. NIPER Guwahati/or the officer supervising the auction reserves to himself the right to withdraw at the actual time of sale, any lot or item that may have been advertised for sale without assigning any reason.
6. The purchasers are required to purchase the entire lot of the scrap materials available at the site and part purchase will not be permitted.
7. The bidder should also have a valid registration under the GST law with the concerned Authority for dealing in scrap items i.e. GSTIN Number and a PAN card (PAN Number) issued by Income Tax Authority. A copy of these documents is required to be submitted before the entry into the auction venue.
8. The Sale Value of the lot will have to be deposited by the purchaser in a single instalment within 15 days from the date of issuance of Sale Order. The payment of Sale Value can be made in cash through Demand Draft in favour of NIPER Guwahati drawn on any nationalized bank payable at Guwahati.
9. Time for lifting of the Sold lot shall be allowed for 15 days only from the date of issuance of Sale Order and under normal circumstances; delivery period will not be extended beyond 15 days.
10. If the goods are not so removed within the delivery period, they shall remain at the purchaser's risk until so removed and the purchaser may be entitled to take delivery of the material only up to further period of one month of the date of expiry of free delivery period on specific extension of such time by NIPER Guwahati on payment of ground rent to the Stock Holder
11. The Purchase shall make his own arrangement (including loading) to effect complete removal of material from the NIPER Guwahati premises with his own labour and at his own expenses within the specified delivery period.
12. Unless or otherwise specifically mentioned in the lot description or terms any ferrous or non-ferrous item found in the lot will be returned to NIPER Guwahati.
13. Screening, picking, sorting, of the lot will not be allowed in the NIPER Guwahati premises. Delivery must be taken as the material came to hand.
14. In course of handling on any other process of delivery of any lot by the purchaser, if any damage is done to the property of NIPER Guwahati, the purchaser shall be liable to compensate the institute to the extent of loss or damage caused and the value thereof must be paid before taking delivery of the material in the lot.
15. The delivery will be witnessed by the representative of NIPER Guwahati. The purchasers are to make their own arrangement for loading.
16. Any special condition which may be announced at the time of auction, to cover any special cases, will form part of these conditions.
17. In the event of any dispute arising in connection with sale, the decision of Director NIPER Guwahati will be final and binding.
