EXPRESSION OF INTEREST

Expression of Interest for Empanelment of Chartered Accountant for Handling NIPER Guwahati's Audit and Other Financial & Accounts related work

The National Institute of Pharmaceutical Education and Research Guwahati (NIPER-G) is a national-level institute in pharmaceutical sciences with a proclaimed objective of becoming a centre of excellence for advanced studies and research in pharmaceutical sciences. The Government of India has declared NIPER as an 'Institute of National Importance'. It is an autonomous body set up under the aegis of the Department of Pharmaceuticals, Ministry of Chemicals and Fertilizers, Government of India.

Expression of Interest (EOI) is requested for the empanelment of Chartered Accountants for handling NIPER-G's Audit and Finance and Accounts related works.

The Bid may be submitted by interested party under **two bid system** namely **Technical Bid** and **Financial Bid**. There must be two separate envelopes duly sealed and super subscribing the subject on envelop. EMD must be kept in technical bid envelop only. Both the envelopes i.e. Technical Bid and Financial Bid must be kept in one bigger envelope and duly sealed and super subscribing the subject '**EOI for Empanelment of Chartered Accountant**' at the top on the envelope. Unsealed envelope will be rejected out rightly. The last date for receiving EOI is **24th June 2025 before 1400 hours (2 PM), and the bids will be opened on the same day at 1530 hours (3:30 PM)**.

SCOPE OF WORK

1. Quarterly Income tax TDS (Form24Q salary & Form26Q Non-salary) returns and any other such return in Connection with TDS required.
2. Preparation of monthly filing (GSTR1, GSTR3B & GSTR 7) and annual GST returns, and any other return related to GST.
3. Preparation of Annual Accounts.
4. Internal Audit.
5. Advising on GST and TDS matters as and when required.
6. Generation of Form 16 and providing calculation sheets of employees.
7. Certification and SoE of externally funded projects, training and workshop, conference etc.
8. Filling of Annual Income Tax return.
9. Professional Tax monthly and annually return.
10. Forex related work.
11. Any other compliances as per requirement. (Mention the name and the rates)

SELECTION CRITERIA

1. The firm must be a member of Institute of Chartered Accountants of India (ICAI) and should have valid full-time certificate of practice issued by the respective institutes.
2. The Chartered Accountant must have done above works for more than 5 clients, out of which at least three should be Central/ State government funded Universities/ Research Institutes.
3. The Chartered Accountant should possess professional expertise, especially in handling Audit and Finance and Accounts related works. The firm must have the requisite infrastructure and be financially sound. It should have offices with easy access to Guwahati.
4. The applicant must be a Partnership Firm of Chartered Accountants as on 01.01.2025, registered with the Institute of Chartered Accountants of India (ICAI) with a valid Firm Registration Number (FRN).
5. Preference will be given to firms that have been continuously engaged in with any Ministry of the Government of India for the last three financial years (i.e. FY 2022-23, 2023-24 and 2024-25),
6. The firm should have at least two full-time qualified Chartered Accountant partners, with at least one partner having 10+ years of post-qualification experience. The firm should have adequate technical and support staff to undertake assignments in multiple state concurrently. A declaration for the same is required to be attached.
7. The firm must be GST registered and in compliance with all applicable statutory requirement.

GENERAL TERMS & CONDITIONS

1. **EMD Deposit:** A refundable Earnest Money Deposit (EMD) amounting to **Rs. 10,000/-**, in the form of Demand Draft/FDR drawn in favour of "The Director, NIPER-Guwahati" issued from a Commercial Bank, will have to be submitted along with the quotation. Offers received without Earnest Money or valid Certificate shall be summarily rejected. The EMD will be returned to unsuccessful bidder after finalization of the above Expression of Interest. In case of successful bidder, the EMD will be converted into security deposit and will be returned without interest after Termination/Completion of the Contract. As per Rule 170 of General Financial Rules (GFRs) 2017, Micro and Small Enterprises (MSEs) and the firms registered with concerned Ministries/ Departments are exempted from submission of EMD.
2. Bids will be opened at the time, date and place as specified in the notice in presence of the Bidders or their authorized agents who like to be present at the time of opening. Authorization letter from the Bidder should be submitted at the time of opening the bid.
3. The bidders should furnish their full postal address. Letters sent by the department in the address mentioned by the bidders by ordinary post shall be deemed to have been received by the bidders and no complaint about non receipt of letters shall be entertained.
4. The bidders should therefore in their own interest contact the respective officers to ascertain the letter issued. Change of address of the bidders should forthwith be notified by the bidders to all concerned.
5. All bids must be accompanied with up-to date valid GST registration certificate without which no Bid will be considered.

6. The empanelled CA Firm may opt to raise the invoice after completion of assigned task within the scope of work.
7. The period of the empanelment shall be 1 year from the date of publishing of empanelled list of Chartered Accountants in the Institute website. This period may be also shorter if the department arrives at a reasoned conclusion that the performance of the selected bidder is below par and the bidder is not able to perform its assigned work. The decision of Director NIPER-Guwahati will be final and binding on both the parties.
8. The department or the empanelled firm is entitled to withdraw or cancel the empanelment by serving notice on either side giving 90 (ninety) days time. Then the Performance security will be returned to the empanelled firm.
9. The Department shall have the right to accept any bid in full or in part.
10. No extra clause/terms & conditions imposed by the Bidders will be entertained by the department.

11. RATES

The bidders should quote the rates against the various activities in the schedule of rates (annexure III). The bidder shall not alter the rates during the pendency of the contract and no enhancement of rate will be entertained. The rates will be valid for a period of 1 year. The Department may invite fresh EOI as and when necessary and deemed fit even before the expiry of 1 year specified above or extend the validity of the contract by another 02 (two) years (one year at a time) i.e. for a total of 03 (three) years without any change in rates and terms & conditions depending on the requirement of the department. The decision of the Department in this regard shall be final and binding.

12. PENALTY FOR NON-PERFORMANCE

If the empanelled firm fails to carry out the work as per the work order or withdraw its rate contract, his/her performance guarantee/security will be forfeited.

13. FORCE-DE-MAJEUR CLAUSE

The contract is subject to Force-de-Majeour clause as applicable under the Law.

14. ADDENDA:

At any time prior to the deadline for submission of EOI, the Employer may amend the EOI Document by issuing addenda. Any addendum issued shall be part of the EOI Document and shall be uploaded in the Institute website www.niperguwahati.ac.in. To give prospective Bidders reasonable time in which to take an addendum into account in preparing their bids, the Employer may, at its discretion, extend the deadline for the submission of Quotations.

15. VALIDITY OF BID:

The Bid shall remain valid for acceptance for a period of 90 days from the date of quotation. Any Bid valid for a shorter period shall be treated as unresponsive and rejected.
