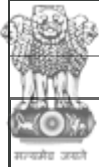

Expression of Interest (EOI) is requested for Hiring Vehicle to transport DBA/J Mice from NII, New Delhi to NIPER-Guwahati.

The Bid may be submitted by interested party under **single bid system** i.e. Technical Bid and Financial Bid must be kept in one envelope and duly sealed and super subscribing the subject '**EoI for Hiring Vehicle to transport DBA/J Mice**' at the top on the envelope. Unsealed envelope will be rejected out rightly. The last date for receiving EOI is **17th July 2025 before 1400 hours (2 PM), and the bids will be opened on the same day at 1530 hours (3:30 PM)**. ELIGIBILITY CRITERIA

Firms must meet the following criteria and furnish necessary documents in support of their compliance to the concerned criteria: -

- The bidder must be in the business of providing services for hiring of diesel driven vehicles for last 5 years reckoned from the last date of the month proceeding the month in which tenders are called for. This should be supported by documentary proof.
- Only commercially registered vehicles with inter-state permits will be considered. In support of this fact, the attested copies of registration certificates of the vehicles under possession of the vendor need to be submitted and the original, if required, may be asked to be produced.
- Must have travel and transport as its nature of business
- Vehicle should be registered within 5 years back from the last date of bid

DOCUMENTS REQUIRED

- Copy of Firm Registration No./Trade License
- Copy of valid GST Registration.
- Copy of PAN No.
- Copy of Registration Certificates of offered vehicle for hiring
- Proforma for Financial Bid as per annexure I

GENERAL TERMS & CONDITIONS

- Payment will be released after successful completion of assigned task within the scope of work.
- The Department shall have the right to accept any bid in full or in part.
- No extra clause/terms & conditions imposed by the Bidders will be entertained by the department.
- RATES: The bidders should quote the rates as per Annexure I (Proforma of Financial Bid).
- FORCE-DE-MAJEUR CLAUSE: The contract is subject to Force-de-Majeour clause as applicable under the Law.
- VALIDITY OF BID: The Bid shall remain valid for acceptance for a period of 90 days from the date of quotation. Any Bid valid for a shorter period shall be treated as unresponsive and rejected.
