Subject: Allotment of Vacant Seats for M.S. (Pharm.) and M.Pharm Programmes Through Phase-2 Counselling for NIPER JEE 2024.

The Phase-1 counselling for the admission to Master Programmes of NIPER JEE 2024 has been completed successfully on 19th July 2024. As the sliding of the candidates from M.S. (Pharm.) and M.Pharm programmes to M.Tech Programmes has resulted in vacancies in M.S. (Pharm.) and M.Pharm programmes, these vacancies will be filled through Phase-2 counselling scheduled on **20th July 2024 at NIPER Guwahati campus from 8.00 a.m.** onwards. Candidates are requested to note the following points in this regard:

- 1. The seat matrix for vacant seats has been notified, along with the category-wise distribution of the seats available at various NIPERs for the Academic Year 2024-25. The vacant seat matrix for M.S. (Pharm.) and M.Pharm programmes can be found in **Annexure 1**.
- 2. Candidates must register for Phase-2 counselling with the following link on or before 7.00 a.m. on 20th July 2024 (https://nipergjee.in/). Candidates who have not registered will not be allowed for Phase-2 counselling. Registration for Phase-2 counselling doesn't guarantee the seat allotment.
- 3. Candidates are informed to come for the Physical Phase-2 counselling (From Rank 1 to 2872 only as per the Public Notice 7, Annexure 1 notified earlier) on 20th July 2024 by 8.00 a.m to NIPER Guwahati campus physically. Seat allotment will be done based on the seat availability in their respective categories at different NIPERs
- 4. Phase-2 counselling will be conducted only for M.S. (Pharm.) and M.Pharm Programmes against the vacant seats only, whereas for M.Tech Programmes the details will be intimated later.
- 5. Candidates who have already used one-time sliding option during M.Tech counselling are not allowed for Phase-2 counselling.
- 6. If a candidate is allotted a seat in Phase-2 counselling, the previously allotted seat will automatically be cancelled, if any.
- 7. If any vacant seats arises after Phase-2 counselling, the procedure for filling the same will be notified accordingly.
