Results of NIPER JEE 2024 (CBT exam held on 15th June 2024)

With reference to the NIPER JEE 2024 Computer-Based Test (CBT) conducted on 15th June 2024 in two sessions i.e., Session-1 (M.S. (Pharm.) / M.Pharm. / MBA (Pharm.) and Ph.D. all programmes except Medical Devices) and Session-2 (M.Tech. programmes such as Biotechnology / PT BT / Medicinal/Process Chemistry, Medical Devices and Ph.D. in Medical Devices), the Merit list of the candidates for admission to the Master programmes (M.S. (Pharm.) / M.Pharm. / M.Tech) and shortlisted candidates for the MBA and Ph.D. programmes at various NIPERs are hereby notified. Details of the respective categories are presented in Tables of the **Annexure 1A to 1C & Annexure 2.**

Note:

1. Candidates are classified as “Qualified” or “Not Qualified” for Master programmes (M.S. (Pharm.) / M.Pharm. / M.Tech) based on the marks secured in the CBT and after applying the qualifying cutoff criteria.
2. Candidates who have not qualified for Master programmes are not allowed to participate in the counselling process.
3. Candidates who have qualified for Master programmes are allowed on RANK basis to participate in the physical counselling process scheduled, tentatively from **16th July 2024** to **20th July 2024**, at NIPER Guwahati. The detailed schedule of the counselling process along with the eligible candidates for physical counselling is given in **Annexure-1A & Annexure 1B.**
4. For candidates who are shortlisted for admission to the MBA programme, the Group Discussion (GD)/interview will be held tentatively on **14th & 15th July**

2024, followed by counselling, subject to the verification of the GPAT or equivalent certificate and other documents. The detailed schedule of the GD is attached in **Annexure-1C**.

5. For candidates who are shortlisted for admission to Ph.D. programmes, the physical interviews will be held tentatively on **21st & 22nd July 2024**, subject to the verification of the GPAT or equivalent certificate and other certificates. The detailed schedule of the interviews for various programmes is attached in **Annexure-2**. Counselling will be held tentatively on **23rd July 2024**.
6. **Candidates who fail to produce a valid GPAT or equivalent certificate at the time of physical counselling are not allowed to participate in the further Counselling process.**
7. Candidates who fail to produce valid reservation certificates (OBC-NCL, SC, ST, EWS, PwD) at the time of physical counselling will be considered under the General category only.
8. Candidates are advised to read the instructions and modalities of the counselling process mentioned in the **Annexure 3**, carefully.
