

Instructions and Modalities for Physical counselling

Process of Physical Counselling for MBA & Master Programmes

(Subject to the declaration of GPAT results)



3.1 Instructions for physical counselling for (M.S. (Pharm.) / M.Pharm. / MBA (Pharm.) programmes (for those who appeared in the Session-1 exam).

- A common merit list (**Annexure 1A**) is released for the candidates appeared in Session-1 under M.S. (Pharm.) / M.Pharm. programmes.
- Also, a separate list of short-listed candidates who opted MBA during the application process is represented in **Annexure 1C**.

3.1A. MBA Counselling Process

- The top 376 candidates (against various reservation categories) among the MBA list will be called for the Group Discussion (GD)/ interview on 14th & 15th July 2024. Based on the cumulative score obtained in the CBT and GD, a separate Merit List will be released for the MBA counselling scheduled on the evening of 15th July for 90 seats (50 Seats in NIPER S.A.S. Nagar and 40 Seats in NIPER Hyderabad). Candidates from the Merit List of 376 who are interested in attending the GD of MBA need to register in the following link: https://nipergjee.in/ (link will be active from 25th June 2024) on or before 30th June 2024.
- Candidates who opted MBA and paid the fees will be freezed and will not be allowed for further M.S. (Pharm.)/M.Pharm./M.Tech counselling. However, candidates who didn't get the seat in MBA will be allowed for further counselling process of M.S. (Pharm.) / M.Pharm. / M.Tech programmes tentatively scheduled from 16th July 2024.

3.1B. M.S. (Pharm.) / M.Pharm. Counselling Process

- Based on the common Merit List, counselling for M.S. (Pharm.) / M.Pharm. programmes will be held from 16th to 18th July 2024 for 718 seats available in all the NIPERs. List of candidates for each day counselling attached in the Table of Annexure 1A.
- Candidates must pay the requisite fees as mentioned in the brochure of Master Programme in Page No. 44 and 45 for confirmation of the allotted seat. Failure to pay at the time of counselling will result in the seat being forfeited and the same will be allotted to the next candidate in the merit list.

3.1C. M.Tech Counselling Process

• Based on the Merit List of Session-2 listed in **Annexure 1B** for M.Tech (Biotech./PT Biotech.), M.Tech. Process/Medicinal Chemistry), and M.Tech Medical Devices, counselling for 222 seats will be held on **19**th **July 2024**.

Note: Candidates who are allotted the seat in M.S. (Pharm.) / M.Pharm. programmes and opted for Session-2 programmes during the application process **will be allowed** for Session-2 counselling scheduled on **19**th **July 2024** without any additional fees.

3.1D. Phase-2 Counselling

Vacant seats in M.S. (Pharm.) / M.Pharm. programmes due to switching of candidates from Session-1 programmes to Session-2 programmes will be filled in Phase-2 counselling tentatively scheduled on **20**th **July 2024**. The preference will be given to the candidates based on their rank in the common merit list.

Note:

- ➤ Candidates who have paid the fee after confirmation of the seat in session1 may also register for phase 2 counselling, in case they are willing to opt for deserved seat without any additional fee by registering in the link https://nipergjee.in/ (will be activated on 19th July 2024)
- ➤ Candidates who are not registered in the link given for phase 2 counselling are not allowed for phase 2 counselling process
- ➤ Candidates who are willing to attend Phase 2 counselling may plan for their accommodation booking accordingly by paying prescribed charges.
- ➤ If any candidate is reallotted a seat in the Phase-2 counselling, the previously allotted seat will be automatically forfeited. The same will be allotted to another candidate based on the merit.
- ➤ If a candidate finds any discrepancies against their hall ticket number, reservation category they may communicate the same via email to contact niperjee@niperguwahati.in on or before 28th June 2024, otherwise the data is consider as final.
- ➤ The proposed dates for counselling as well as GD/interviews are based on understanding that the GPAT-2024 results will be declared on or before 8th July 2024 (as per information on the website of NBEMS).

3.2 Physical Interview and Counselling for Ph.D. Programmes

Physical interview for the short-listed candidates (Annexure 2) opted for Ph.D. programmes will be held tentatively on 21st & 22nd July 2024. Considering the cumulative score from CBT and interview, a separate merit list will be released for each Ph.D. programme by 22nd July 2024 evening and counselling for those candidates will be conducted on 23rd July 2024. Candidates need to pay the prescribed fee as mentioned in the PhD brochure, page No. 46 to confirm the seat.
