Terms & Conditions of Placement Committee – NIPER Guwahati

1. Students who are willing to get placed should register with the NIPER GUWAHATI PLACEMENT COMMITTEE. Only those students who have registered are eligible to participate in the placement activities.
2. Students who have poor academic performance and poor attendance in any semester may not be allowed to appear for the campus placements.
3. Students are advised to have decent dress and pleasing manners when they appear for the placement activities.
4. If a candidate who has forwarded his/her resume for a particular company and decides not to appear for the test/interview, he/she should take the permission for not attending the interview. This will not only enable the placement committee to give an accurate estimate of the number of candidates appearing for the interview to the company, but also help other students who would otherwise miss out on a good chance.
5. If the student has been selected in the campus interview and has received an appointment letter, then he/she **cannot apply again** and his/her name is removed from the placement committee, even if he/she rejects the previous job offer.
6. Students pursuing further studies in India or abroad are not eligible to attend the interviews. The students are hereby informed that they should not avail the facilities of NIPER GUWAHATI PLACEMENT COMMITTEE for stop-gap arrangements.
7. Students who have applied or secured a job through off campus application should inform the placement coordinator immediately. Such students will not be allowed to take part in further placement activities and their names will be removed from the placement committee register.
8. Once a student receives an appointment letter it is assumed that the student will join the organization. If the selected students do not join the organization, then they should inform the placement committee immediately. Any queries must be clarified through the placement committee only.
9. The Director of NIPER Guwahati reserves the right to disallow any student to appear for campus interview, on disciplinary grounds.
