1. Candidates of Indian nationality can only apply for these posts.

5. Incomplete application or those without relevant supporting documents (self-attested copies of Date of birth/Degrees/ Certificates/ Mark sheets/Experience Certificates/documents, etc.) will be rejected.
6. On the recommendation of the Screening/Selection Committee, the Competent Authority may **relax the experience for the candidates having less than 5 years of experience** in exceptionally meritorious cases and may be considered for **Assistant Professor (Adhoc)**.
7. Fulfilment of qualifications and experience is an essential requirement. The candidate will be called for ONLINE interview or stated above while progressing ahead in the stage(s) of recruitment / selection, following the standards in general. As stated, the Institute is free to set the benchmark and call only the eligible candidates for the ONLINE interview.
