### Specifications for Furnishing of Reception Area

National Institute of Pharmaceutical Education and Research (NIPER) is the first national level institute in pharmaceutical sciences with a proclaimed objective of becoming a centre of excellence for advanced studies and research in pharmaceutical sciences. The Government of India has declared NIPER as an 'Institute of National Importance'. It is an autonomous body set up under the aegis of Department of Pharmaceuticals, Ministry of Chemicals and Fertilizers, Government of India. The Institute is conceived to provide leadership in pharmaceutical sciences and related areas not only within the country, but also to the countries in Southeast Asia, South Asia and Africa. NIPER is a member of Association of Indian Universities and Association of Commonwealth Universities. The permanent campus of NIPER Guwahati is located at Sila Katamur (Halugurisuk), Changsari, Kamrup, Assam.

Our institute has developed a beautiful spacious new campus in Changsari, Kamrup district for benefit the students and Research Scholars and PhD students. Now we are planning to develop a beautiful pleasant and attractive reception area on the ground floor of the main building, and the same should project the culture of Assam. For this purpose, we are now approaching competent, efficient experienced sources who can fulfil the dreams of the institute to have a beautiful reception area. - We propose to have a first base structure using plywood materials. The estimated area
  would be between 90 to 100 square feet. The prospective bidders are required to make
  their own arrangements for measuring the area and decide suitable structure, for
  creating the base structure. The competitive rates can be quoted per square feet by
  indicating total cost.
- The second base structure will be with bamboo paneling. The approximate area will be

98 - 100 sq. feet.

- The countertop is required to be fabricated using composite stone. The estimated area will be 55 65 sq feet.
- It will be the responsibility of the prospective bidders to estimate the required wiring and electrification, and lumpsum cost to be indicated.
- We further propose to have a beautiful, artistic, attractive, chandelier with bamboo finish.
- We propose to have the projection of institute's logo in the reception area for which the prospective bidders are required to offer competitive rates considering this as a job.
- Further the prospective bidders are required to undertake paint job with acrylic finish for which lumpsum competitive rate may please be quoted.
- The proposed work of decorating reception area is a turnkey job. The prospective bidders are to ensure the cost towards accessories if any will be taken care while submitting the quotation. The institute will hand over only the site proposed to be constructed as reception area, all other requirements need to be taken care by the bidders.
- As the institute cannot make any separate payments towards designing and implementation, the prospective bidders are required to quote the cost which is inclusive of cost towards designing and implementation.
- Keeping all our requirements in view the bidder can offer their best solutions for above project work of creating a beautiful reception area which projects culture of Assam.

- The bidder is expected to visit the institute to have their own measurements and plans and to inspect the proposed area in which the institute is planning to create a reception area, and which should project the rich cultural heritage of Assam.

  withquantities, rate per unit and total cost etc. particulars should be mentioned. The cost
  quoted should be all inclusive of final cost which can be compared with other
  competitive bids. The total cost for entire work will be compared with other competitive
  bids received.
- After preparing quotation on above lines, please indicate final total all-inclusive cost
  which includes components like Taxes etc. For undertaking the job work of creating
  reception area on the ground floor of main building.
- As a matter of policy Institute cannot consider any requests for making advance payments. All payments will be made after successful completion of contractual obligations.
- The work carried out will be subject to 3 years comprehensive warranty.
- Director reserves the right to accept or reject any quotation without assigning any reason.
- Director further reserves the right to withdraw the tender at any stage.
