National Institute of Pharmaceutical Education and Research (NIPER), Guwahati is an Institute of National Importance set up by an Act of Parliament under the aegis of Dept. of Pharmaceuticals, Ministry of Chemicals & Fertilizers, Govt. of India, to impart higher education and undertake advanced research in the field of Pharmaceutical Sciences and Technology. NIPERG is establishing a state of art Animal house facility for small animal experiments, breeding and Toxicological studies with the financial support from Department of Pharmaceuticals, the Ministry of Chemicals & fertilizers, and Ministry of DoNER Govt India under the STINER scheme.

NIPER G intends to obtain OECD GLP certification for the aforementioned facilities and intent to call expressions of interest (EoI) from any consultancy agencies or registered entities or any individuals having relevant experience to guide the team of NIPER Guwahati in the following duties and responsibilities. The Consulting registered Organizations or registered entities or any interested individuals may fill the application in two parts *i.e* (a) Technical details and (b) Commercial details as per the formats enclosed in Annexure 1 and Annexure 2 in separate sealed envelopes. The sealed covers superscribed with "EXPRESSION OF INTEREST TO ENGAGE A GLP CONSULTANT AT NIPER Guwahati", should reach to the Registrar, NIPER Guwahati, Silla village, Changsari, Guwahati-781101, Assam by 12.01.2023 ,02.00pm and the EoI will be opened on same day.

### **Duties & Responsibilities**

- 1. To assess the existing facilities and identify gaps if any, & suggest corrections
- 2. To plan a time bound GLP implementation and Certification program
- 3. To impart required training of OECD GLP documents to all functional groups
- 4. To advice and guide for preparation of GLP documents such as SOPs, Forms, documents etc.
- 5. To oversee and advice study plans, conduct of GLP compliant Toxicity studies, and study reports
- 6. To facilitate GLP certification for all drug development studies (*In vitro* & *In vivo*)
- 7. Any other assignment given by the Director connected with above work.

### **Essential Requirement:**

- 1. Consulting registered Organizations (CRO) or registered entities who registered under any Indian law and applying in response to this advertisement should have relevant experience of undertaking this kind of jobs and should be in this line for a period of at least for five years. Individuals having relevant experience may also apply.
- 2. The applicant should be well qualified and experienced scientist, capable of executing the responsibilities required for completing the job detailed through this document.
- 3. The applicant must be doctorate in Life Sciences or pharmaceutical sciences with minimum 8 -10 years of experience in management of GLP Certified Toxicology facility for drug development. In case if CRO or registered entity is participating, the firm or registered entity should have at least one staff with the minimum qualification as specified for individual applicant.
- 4. Proven record in Obtaining GLP certification for minimum of one toxicology facility either in the capacity of individual or registered entity or CRO
- 5. Should have Proven record of GLP training By NCGMA for an individual or registered entity. In case if it is CRO, the staff who is having qualification as mentioned in the SN.3 should have NCGMA certificate (enclose the proof of training certificate)
- 6. Should have proven record to impart training ON GLP principles.
- 7. If bidding as an individual is participating for the EoI, then the maximum age should not be more than the 63 years as on last date of the application (Proof either birth certificate or SSC must be enclosed only for individual applicant).
