- 1. मूल्य / PRICE: Please quote your rate of all kinds of Risks covered FOR NIPER-Guwahati basis. Please also ensure providing Breakup cost for all individual components for our records.
- 2. In case the quotation submitted is in foreign currency the cost/expenditure incurred for Indian components will be paid in Indian currency only. Accordingly, please submit your offer in Indian currency payment for the components whose costs can be paid in Indian currency.
- 3. ईएमडी जमा / EMD Deposit: An Earnest Money Deposit (EMD) amounting to 3% of the quoted value rounded off to nearest INR 100, in the form of Demand Draft drawn in favor of "Director, NIPER-Guwahati" issued from a Commercial Bank, will have to be submitted along with the quotation. Offers received without Earnest Money or valid Certificate, if any, for exemption, shall be summarily rejected.
- 4. वितरण / DELIVERY: The ordered material(s) is/are required urgently and hence, kindly specify the shortest possible delivery schedule. - 9. This institute is registered with Dept. of Scientific & Industrial Research (DSIR), Govt. of India and concessional customs duty and GST & IGST are leviable vide notification no. 54/2002-Customs on all imports covered under notificationNo.51/96-Customs dated 23.07.1996, Notification No.47/2017-Integrated Tax(Rate) and Notification No.45/2017-Central Tax (Rate) both dated 14thNovember, 2017.

In exceptional cases, the bidders may be requested by the institute to extend the validity of their bids up to a specified period. The bidders, who agree to extend the bid validity, are to extend the same without any change or modification.

In case the day up to which the bids are to remain valid falls on or subsequently declared a holiday or closed day for NIPER-Guwahati , the bid validity shall automatically be extended up to the next working day.

- 16. परफॉर्मेंस सेक्युर्टी / Performance Security: A performance security against the warranty period equivalent to 3% of the total order value will have to be furnished by the selected supplier in the form of Payee Demand Draft / Fixed Deposit / Bank Guarantee, in favour of "Director, NIPER-Guwahati" issued by a Commercial Bank within 21 days from the date of installation of the ordered item (s). The performance security shall remain valid for the warranty period starting from the date of installation plus additional 60 days of the claim period for the institute.
- 17. स्वीकृति और अस्वीकृति / Acceptance & Rejection: The acceptance of the quotation will rest with the Director, NIPER-Guwahati, who does not bind himself to accept the lowest quotation and reserves the right to himself to reject or accept, partially or all the quotations received, without assigning any reason. The Director, NIPER-Guwahati further reserves the right to withdraw the tender or part thereof or modify the requirements without assigning any reason and the right to relax any of the conditions in the best interest of the Institution.
- 18. माल भाइ। एवं बीमा / Freight and Insurance: The items to be supplied will be insured by the vendor at his own cost against all risks of loss or damage from the date of shipment till such time it is delivered at NIPER-Guwahati. The institute requires insurance coverage on warehouse to warehouse basis to cover all type of en-route risks. In other words, the insurance coverage starts from manufacturer's premises to NIPER-Guwahati premises. In order to ensure lodging insurance claim within stipulated time, supplier's authorized representative must be present in the institute on the day of delivery of the consignment, to check the package/s to ensure that the same is received without any externally visible damages. The supplier has to arrange for customs clearance from destination airport in India and arrange for its safe onward transmission to NIPER-Guwahati. The Institute will provide connected documents like Duty Exemption certificate for availing Duty Exemption, Authorization letter etc. It may further be ensured that insurance coverage should be from supplier's warehouse till NIPER-Guwahati institute premises and should not end at destination port of clearance.
- 19. The customs clearance if any has to be undertaken by the supplier and has to make their own arrangements for such clearance. The institute will provide only Duty exemption certificate and other required documents for handling customs clearance at port of destination. Please note that the institute does not have any Authorized customs clearing agent in any of the ports in India.
