4. The Vendor should be a reputed supplier of books.
5. Supply of the books should be made strictly as per specifications given in Annexure-1.
6. Vendors may quote for the latest edition which will be preferable. Indian/South Asian/ paperback edition may also be considered.
7. The books must be original and not any pirated copy.
8. NIPER-Guwahati reserves the right to cancel the order in the event of delay in supply beyond the stipulated period
9. Price of the items should be quoted as per given format (Annexure -2). Price amount should be mentioned both in figures and words.
10. Price of the item quoted in the tender should be inclusive of all like taxes, freight etc.
11. The prices as quoted would be considered as the final prices for evaluation of the bid. In any case, upward revision will not be allowed.
