Duration of Warranty clarification:

Sr. No.	Original Terms and Conditions	Amended terms and Conditions
1)	This institute as a matter of policy would like to have five years comprehensive warranty. While offering Five years comprehensive warranty, the suppliers must essentially indicate the breakup cost implications for second year and third year and fourth and fifth Years separately.	The bidders are expected to quote for one-year of standard warranty applicable from the date of satisfactory Installation and acceptance of material. The warranty period starts from the date of Installation & commissioning and certified by the Indenting officer
2)	The payment towards second year and third year, fourth and fifth year warranty will be paid only after successful completion of warranty obligations at the end of second year and third year, Fourth and fifth year respectively.	The bidders are further required to indicate separately cost towards additional warranty for second year and third year. Depending on the need the institute will consider inclusion of availing additional warranty as per the accepted warranty amount.
3)	This is an essential condition for comparing the cost implications of item offered with other bids.	Further, the bidders are also required to quote for fourth and fifth year CMC and AMC, which can be availed by the institute after the expiry of warranty period.

The other terms and conditions will remain unchanged as mentioned in the tender document.
